## DESIGN RETAINER AGREEMENT – CUSTOM

This Agreement is entered into as of the date set forth below by and between Romanelli and Hughes Building Company (R&H) and jointly and severally by those designated below as the Buyers (Buyers).

In consideration of the mutual covenants contained herein, Buyers and R&H agree to the following terms and conditions:

The undersigned hereby retains R&H to prepare plans and specifications for proposed construction of a custom-built home. Upon signing the Design Retainer Agreement and payment of the Design Retainer Fee set forth below, the design process will commence and subsequent meetings will be proposed to review the design as developed.

Design retainer services include:

- Planning meetings and needs analysis
- Lot or building site review
- Floor plan layout(s)
- Exterior elevations(s)

**Retainer Amount:** **\$7,500.00**

The Design Retainer Fee is for preliminary design services for custom homes. Design services are billed at \$150.00/hr. If preliminary design exceeds the retainer amount subsequent retainers in \$7,500 increments shall be required to continue. If preliminary design is terminated the retainer fee less design services shall be refunded.

Upon approval of the schematic design, a design development fee may be required to be paid to develop a set of drawings to be used in securing bids for a preliminary project budget.

Bid documents include:

- Finished floor plans including foundation and roof plans
- Completed exterior elevations
- Needed sections and details
- Structural design
- Plot plan
- Any other items needed to obtain firm bids

**Design Development Fee:** **\$2.50 per sq. ft** – based on first and second floor living areas

Once our standard home construction agreement is executed, the Design Retainer Fee and Design Development fee shall be credited toward your deposit for that agreement. We will complete a full set of construction documents for the use in securing a building permit, and ultimately construction of your new home.

Any changes after bidding and/or construction drawings are completed may result in additional fees and/or construction costs.

**ADDITIONAL PROVISIONS:**

- Buyers acknowledge and agree that designs and plans are provided for the fair use of the Buyers executing this agreement, but remain the exclusive property of Romanelli & Hughes Building Co. and cannot be used, duplicated or altered without R&H's written permission. \_\_\_\_\_ / \_\_\_\_\_

- DEPOSIT:** If the Buyers and R&H enter into a purchase agreement within 30 days after R&H notifies the Buyers of completion of the design, the Design Retainer Fee and Design Development Fee shall be used as a credit towards the deposit required under the building contract. If the Buyers and R&H do not enter into a building contract within such 30 day period, then R&H shall retain the fees as payment for services rendered under this Agreement.
- DESIGN DEVELOPMENT FEE:** R&H shall notify the Buyers of the requirement to more substantially complete the design drawings in order to complete the pricing towards a building contract. This is a non-refundable fee and does not infer ownership of the design and drawings by the Buyers. All designs and drawings remain the property of the Seller.
- REVISION FEE:** R&H shall notify the Buyers when design parameters exceed the initial design concepts and for which a non-refundable revision fee will be required to be paid by the Buyers before R&H continues with the design.
- AGREEMENT COMPLETE:** This Agreement fully and completely sets forth the agreement between the Buyers and R&H. The Buyers acknowledge that R&H has made no representations or other commitments to the Buyers except as contained herein.
